The Presiding Officer recognized the Majority Floor Leader for explanation of matters related to sine die adjournment of the House of Representatives.

The Majority Floor Leader stated that because a resolution setting the date of sine die adjournment had not been voted upon by the House, in his opinion, it was proper for notice to be served for a possible motion to reconsider without requiring that such motion be taken up immediately.

As such, Representative McCullough withdrew his motion to reconsider the vote whereby **SB 935** failed.

Representative Reynolds raised a point of order stating that Representative McCullough had moved to reconsider the vote and Representative Proctor had subsequently moved to table the McCullough motion, and therefore the House should take immediate action on the pending motion to table.

The Presiding Officer stated that the motion by Representative McCullough had been withdrawn and ruled the point not well taken.
