Fifteenth Legislative Day, Wednesday, February 26, 2014

Announcing the passage of **SBs 1077, 1150, 1151, 1152, 1153, 1159, 1168, 1215, 1243, 1377, 1510, 1520, 1542, 1585, 1610, 1654, 1701, 1754, 1777, 1809, 1970, 1978** and **2045**. The measures were introduced and read for the first time.

SB 1077 – By Crain of the Senate and Grau of the House.

An Act relating to attorneys' lien; amending 5 O.S. 2011, Section 6, which relates to attorneys' lien procedures; making language gender neutral; requiring filing of certain notice; specifying contents of certain notice; and requiring certain action to be commenced within specified time period.

SB 1150 – By Mazzei and Fields of the Senate and Sears of the House.

An Act relating to privilege tax; amending 68 O.S. 2011, Section 2370.1, which relates to credits against the bank privilege tax; limiting time period during which certain credits may be claimed; and providing an effective date.

SB 1151 – By Mazzei and Fields of the Senate and Sears of the House.

An Act relating to income tax; amending 68 O.S. 2011, Section 2357.101, which relates to tax credits for certain reinvestment of specified profit; limiting time period during which credits are allowed; and providing an effective date.
