Representative Grau moved to amend **SB 1848** by striking the enacting clause, which amendment was withdrawn.

Representative Williams raised a point of order as to why the Presiding Officer was providing unsolicited procedural advice on the bill under consideration, to which the Presiding Officer responded that it is the prerogative of the Chair to do so.

Representative Morrissette raised a point of order as to whether the Presiding Officer would provide procedural advice on every future motion, to which the Presiding Officer responded that it would be up to the discretion of the Chair.

Representative Morrissette raised a point of order as to whether the previous rulings would be published as House precedents, to which the Presiding Officer responded that it would be up to the Speaker.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. The State Board of Health shall adopt standards related to medical screening exams and the evaluation of each emergency room patient. Standards shall include the determination of what emergencies require immediate care under EMTALA standards and what cases qualify for referral for later treatment by a primary care physician.”, and by relettering the subsequent subsections.

Representative Grau moved to table the Cox amendment, which tabling motion was declared adopted upon a division of the question.

Representative Morrissette raised a point of order as to where in the House Rules the type of majority required to carry a motion to table is established. The Presiding Officer stated that the purpose of a point of order is to draw attention to a deviation from the requirements of the House Rules and not to answer general procedural questions.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following subsection:

“J. The State Board of Health shall adopt standards related to the performance of neosurgical procedures and post-procedure follow-up care.”, and by relettering the subsequent subsections.

Representative Grau moved to table the Cox amendment, which tabling motion was declared adopted upon a division of the question.

Representative Morrissette raised a point of order as to how the Presiding Officer determined the order in which to recognize members seeking recognition, to which the Presiding Officer responded that such a determination falls within the prerogative of the Chair.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. The State Board of Health shall adopt standards related to the performance of urological surgery.”, and by relettering the subsequent subsections.

“J. The State Board of Health shall adopt standards relating to athletic physicals performed on any student enrolled in the schools in the State of Oklahoma. Such schools shall include any student enrolled in public, private, charter, virtual and home schools, and shall also include any student enrolled in colleges and universities.”, and by relettering the subsequent subsections.

Representative Grau moved to table the Cox amendment, which tabling motion was declared adopted upon a division of the question.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. Recognizing that disease transmitted through an enteric born illness is a public health issue, the State Board of Health shall oversee construction and remodeling of all

sewer systems maintained in state owned or leased building, including the state capitol. The State Board of Health shall also adopt rules and regulations relating to the construction and remodeling of such sewer systems.”, and by relettering the subsequent subsections, which amendment was withdrawn.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. The State Board of Health shall adopt standards related to potential space flight health hazards pursuant to space flight activity developed by the Oklahoma Space Industry Development Authority.”, and by relettering subsequent subsections.

Representative Grau moved to table the Cox amendment.

Representative Cox raised a point of order as to whether the amendment was germane to **SB 1848**, which point was not well taken because the tabling motion was a prior motion.

Representative Morrissette raised a point of order as to why the point of order regarding germaneness of the amendment was not immediately ruled upon by the Presiding Officer, to which the Presiding Officer responded that the tabling motion was a prior motion.

Representative Grau pressed his motion to table the amendment, which tabling motion was declared adopted upon a division of the question.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. The State Board of Health shall adopt standards related to the performance of family physicians and any office procedures performed by such physicians.”, and by relettering subsequent subsections.

Representative Grau moved to table the Cox amendment, which tabling motion was declared adopted upon a division of the question.

Representative Cox moved to amend **SB 1848** by inserting on Page 7, Line 16 the following language:

“J. The State Board of Health shall adopt standards related to the performance and post-procedure follow-up care of cardiac catheterizations.”, and by relettering the subsequent subsections.

Representative Grau moved to table the Cox amendment, which tabling motion was declared adopted upon a division of the question.

Representative Fisher moved to amend **SB 1848** by inserting new Sections 2 and 3, and by renumbering subsequent section.

Representative Reynolds moved to put the Previous Question.

Representative McDaniel (Jeannie) raised a point of order as to whether the Fisher amendment was germane to **SB 1848**.

Representative Inman raised a point of order stating that a pending motion to put the Previous Question did not prohibit the Presiding Officer from taking up a point of order pertaining to the question of germaneness.

The Presiding Officer ruled the point not well taken because the point was not raised at the proper time. A point of order yields to motions having a higher precedence than the motion from which the point of order arose.

Representative Inman appealed the ruling of the Presiding Officer receiving the required 15 seconds.

“The question is, shall the decision of the Presiding Officer be the decision of the House? All those in favor signify by voting ‘Aye’; those opposed ‘Nay’. The vote is now in progress.”
