license; providing for renewal; setting renewal fee; setting qualifications for license; establishing information to be provided for licensure; stating disqualifications for licensure; authorizing suspensions; stating reasons for suspension; amending 59 O.S. 1689, which relates to Electrical Hearing Board; including authority over poultry house contractor license; adding certain reason for revocation of license; providing for codification; providing an effective date; and declaring an emergency.
