The portion of State Highway 20 in Owasso beginning at the junction of State Highway 20 and 145th E Avenue extending west to the junction of State Highway 20 and U.S. Highway 169 shall be designated as the “United States Submarine Veterans Memorial Highway”. The Department of Transportation shall cause suitable markers bearing that name to be placed on the highway.”, which amendment was declared adopted.

REMARKS

Upon unanimous consent request of Representative Wright, the remarks made by Bishop Robert E. Hayes, Jr. on Monday, February 29, 2016; were ordered printed in full as follows:

“Thank you Representative Wright for this gracious invitation.

‘Great is thy faithfulness, O God my Father, there is no shadow of turning with thee; thou changest not, thy compassions, they fail not; as thou hast been, thou forever wilt be. Great is thy faithfulness! Great is thy faithfulness! Morning by morning new mercies I see; all I have needed thy hand hast provided; great is thy faithfulness, Lord, unto me!’ (Thomas O. Chisholm, 1923)

The year was 1620. To be even more exact it was November 11, 1620. A tiny ship anchored off the coast of what is now Provincetown Harbor near Cape Cod, Mass. On board were 101 passengers seeking religious freedom from England and King James VI. The ship was known as the Mayflower, and in the belly of that tiny ship a group of passengers gathered to draw up a document that would determine how they would govern and rule themselves in this new land. They were later called Pilgrims, and of the 101 people on board, 41 of them signed this first piece of governing legislation and called it the Mayflower Compact.

It is interesting to note that they didn’t begin this manuscript with ‘To whom it may concern.’ Nor did the document begin with, ‘Dear Sir or Madam,’ or, ‘To His Majesty King James.’ Instead, the first words of the Mayflower Compact began with these words, ‘In the Name of God, Amen.’ In this our time some might say what an unusual way to begin a document, but those early Pilgrims knew that it was the only place to start. God had delivered them and brought them safely over the Atlantic—66 days of uncertainty and storms, actually blowing them off course from their original destination of Virginia, and finally, with this new land in sight, a land that would provide them a safe place to practice their faith, it was with great respect and reverence they began with these words, ‘In the Name of God, Amen.’

That phrase becomes our clue this afternoon for what this nation and this state are all about. The thing that has made America great and our beloved Oklahoma great has been our acknowledgement of the God who created us all. Since 1907 God has been a very prominent presence in the lives of the people of Oklahoma, and how reassuring it is to know that before you begin your sessions, before you take one vote on any single bill, you, like those Pilgrims, acknowledge God. As an aside, you might want to know that the Oklahoma City Thunder basketball team is the only NBA team that has prayer before each game. I might add that I’ve been invited to pray four times before a game and each time I’ve prayed the team has won! Someone might remind them to invite me back during the playoffs because I think we are going to need it.

Centuries before these Pilgrims landed, a wandering prophet by the name of Jesus said, 'If you heed these words of mine it will be like building your house on a rock. The rains will come and the winds will blow and beat up against the house but it will stand.'

Whatever success we will have as a state, whatever accomplishments you will experience as a legislative body, it will be due in large part to understanding where and from whom our strength comes. For it is in God our Creator that we live and breathe and have our being.

I leave you with a fascinating truth that cannot go unnoticed: The first four words of the Bible hold a clue that opens the door to a valuable secret of life: In Genesis 1, the first words are: 'In the beginning, God.' I don't believe it's just a coincidence or happenstance that those words are there. It is telling us, reminding us that anything and everything is only successful when God—who is known by many names becomes our priority.

Let us pray:

Gracious God, Creator of all things, giver of all goodness; we gather here to lift your name above all names and to acknowledge your presence among us.

Remind us that by placing you first in everything we follow the traditions of those who have gone before us, and in doing so have made our nation and our State institutions of greatness.

May these representatives who have been called of God and elected by their peers to special responsibilities be empowered to perform the many tasks that are needed for the welfare of the State of Oklahoma and for the Kingdom of God as well.

Give them wisdom and understanding of the important decisions they must make, being resolved to work together in unity and purpose to achieve the best outcome for all our citizens.

We thank you for your faithfulness O God, and for all those who this day join me in saying, 'In the name of God, Amen.'"
