Representative Cannaday raised a point of order as to whether the title of the measure displayed on the voting board accurately reflected the substance of **SB 1128**. The Presiding Officer stated that any corrections to the title of the measure would be made by the Senate prior to enrollment and presentation of the measure to the Governor.

Representative Rousselot raised a point of order as to whether the voting board should be modified to accurately reflect the title of **SB 1128**. The Presiding Officer reiterated that the Senate does not customarily update the title as it proceeds through the legislative process but that the title of the measure would be updated by the Senate prior to enrollment. The Presiding Officer ruled the point not well taken.

Representative Perryman raised the point of order that the title of the bill was updated and the board was not.

Representative McCullough raised a point of order as to whether the preceding points of order were dilatory. The Presiding Officer stated that the points were not yet dilatory and would recognize a similar point of order raised by Representative Perryman.

MOTION

Upon request of Representative Strohm, the remarks made by Pastor Blake Gideon on Thursday, April 14, 2016 are printed in full as follows:

“I have been praying all week about what God would have me share, and I can sincerely say that what I am going to say this morning is from the Lord. I have asked the Lord to guard my heart that there is no personal agenda of my own and that it is being offered in humility. I want God’s will to be done and certainly not my own.

The scripture that the Lord has laid upon my heart is found in Isaiah 6, starting in verse 1...

¹ In the year that King Uzziah died I saw the Lord sitting upon a throne, high and lifted up; and the train of his robe filled the temple. ² Above him stood the seraphim. Each had six wings: with two he covered his face, and with two he covered his feet, and with two he flew. ³ And one called to another and said:

‘Holy, holy, holy is the LORD of hosts; the whole earth is full of his glory’

⁴ And the foundations of the thresholds shook at the voice of him who called, and the house was filled with smoke. ⁵ And I said: ‘Woe is me! For I am lost; for I am a man of unclean lips, and I dwell in the midst of a people of unclean lips; for my eyes have seen the King, the LORD of hosts!’

I believe the greatest need of our nation is to once again see a true vision of the holiness of God. Three times in this passage the word, ‘Holy,’ is mentioned, which characterizes God as a thrice-holy God. Anytime a word in Scripture is repeated, it places emphasis upon that word and on the subject that is being addressed. The holiness of God is the emphasis in this passage. And, it is the very holiness of God that Isaiah wants us to see here.

When we talk about the holiness of God, it also brings up another word, the word, ‘Immutability’. Immutability refers to the unchanging character of God. He is immutable. He doesn’t change. He is the same yesterday, today, and forever. So in regards to God’s holiness, it is unchanging. This is one of the major emphasis of the text.

There are passages of Scripture in the Old Testament that have been fulfilled. As a matter of fact, when you read about the ceremonial laws and the judicial laws in the Old Testament, the laws that we find in the book of Leviticus, a lot of people will draw those out for proof texting. This is when someone lifts a passage out of its immediate context or the context of the Bible as a whole and uses it to form an argument. For example, someone wanting to argue against the legitimacy of the Old Testament might use the following example ‘If your child disobeys, then you can go out and stone him or her.’ They say, ‘If I am to obey others portions of Scripture, then why aren’t we obeying this passage and others that are similar?’ At best this is poor hermeneutics, and at worst, a blatant twisting of Scripture.

What we need to understand is that many of the Old Testament passages, such as the ceremonial laws and the judicial laws have been fulfilled in Christ. The purpose of these passages is to point us to Christ. They highlight the holiness of God. When a person understands the holiness of God, they are not driven to obey the law, to the contrary, they are driven to grace because they realize they can’t obey the law perfectly. Therefore, we

need someone outside ourselves. The purpose of the law is to point us to Christ who is the embodiment of the holiness of God.

However, there are truths in the Old Testament that have not been fulfilled, and there are things in the Old Testament and the New Testament that never change. Many of the items that you address in this House, may be referred to as secular or common. Yesterday, I heard a debate on Imminent Domain. Well, the Bible doesn't really say a whole lot about that, even though we should pray about everything and even though there are some biblical principles that could be applied. In regard to the common things, you ought to pray about them, but there is freedom in the decision and freedom in the debate. But you also have a responsibility that if you are not careful, you will treat as common that which is not common – and that is the sacred.

Never forget that many of the bills that come on this floor are not common issues, they are sacred issues, and we are not to treat the sacred as common. And we are not to treat the common as sacred. Because if we do, we begin to lose sight of what is truly holy. For example, we talked about the judicial and ceremonial law being fulfilled in Christ, but the moral law of God has not changed. Why... because it is the very morality of God. God's morals never change. When we refer to the moral law of God, what we are specifically referring to is the Ten Commandments. We are not to obey the Ten Commandments as a way of salvation. Man cannot earn salvation through good works. Salvation is only found by grace through faith in the Lord Jesus Christ. But once we are saved, we are to live according to the moral law of God. So the Ten Commandments are not to be shattered. They are to be upheld.

Another thing that has not changed concerning the holiness of God is God's definition of marriage. In the book of Genesis, God clearly states that marriage is between one man and one woman, forever, and they shall never be separated. We are not to treat the sacred as common. We are not to redefine marriage - we are to honor marriage as it is defined in Scripture.

Another item that is holy to God and is unchanging is His view of the womb. Some would say that these are partisan issues, but quite frankly, they are biblical issues; they are sacred issues. The Bible states, according to the Psalms 139, that we were woven together in the womb. So the womb is not to be violated. The womb is to be protected. Make no mistake about it, when you deal with the sacred on this floor, do not treat the sacred as common. You have freedom in the common, but you do not have freedom when regarding the sacred.

Lastly, salvation in Christ alone is the only true way to salvation. There are not many roads that lead to Heaven; there is one, salvation in Christ. Christianity is the only religion, if you want to use that term, that teaches that man cannot work his way up to God, but God came down to man in the person of Jesus Christ. Mankind's only hope of being saved is to place his or her faith in Christ as Lord and Savior in repentance of sin.

I conclude with this remark, God is holy – thrice holy. He is immutable. His moral law has not changed. His definition of marriage has not changed. The sacredness of the womb has not changed. His salvation is still through faith in Christ, and that will never change. These things will never change. They are sacred issues, and my prayer is that you will not treat the sacred as common. And you will allow your decisions to be made in line with the Word of God.

It is inevitable that persecution will come to America. However, I am praying for spiritual awakening to come before that happens. But one day persecution will come and

persecution will primarily be based upon the issues I shared with you today. And I believe pastors in pulpits will be the primary focus of that persecution.

A word of encouragement: thank you for the strong stand that many of you have taken. Praise God for you. A word of warning: make sure you are not guilty of being the very instrument that introduces persecution in Oklahoma by the Bills that you pass.

Heavenly Father, I thank you so very much for the opportunity to speak. And, Lord, I do pray that everyone will sense my desire to be faithful to You. I am not here to please man. I am just here to honor You, Lord. I am just your humble servant. I am a nobody. Thank you for this opportunity. And, Lord, I do pray for spiritual awakening to come to America. That once again, you would revisit us in the power of Your Holy Spirit and that salvation would rain down upon our land for it is dry and thirsty. I pray that salvation would rise up. I pray that once again, the morality of our nation would be defined and characterized by biblical truth. I don't expect the government to be the church. The government is not the church, and the church is not to shift its responsibility to the government. The church is to be the church. And to be quite frank, the reason we are in the condition that we are in is perhaps, the church has been silent and has failed in its responsibility. So I am not asking for the government to be the church. I do want the church to be the church. And I am asking for Christians that serve as ministers in the government to stand boldly upon their convictions on the truth of God's Word, and not treat the common as sacred, and not treat the sacred as common. Bless us with awakening and revival, Oh God. I believe in the prayer of intercession. You have used the prayer of Ezra. You have used the prayer of Nehemiah. You have used the prayer of Hezekiah. You have used the prayers of Moses; all these prayers to bring reform to Your people. And I pray that you will use my prayers and the prayers of others to bring reform to this nation for Your glory. In Jesus' name, Amen."
