Twenty-first Legislative Day, Monday, March 12, 2012

The House was called to order by Speaker Steele.

Representative Shelton moved to amend **HB 2388** by inserting a new Section 1 to read as follows and by renumbering subsequent sections:

“SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 5-111.2 of Title 26, unless there is created a duplication in numbering, reads as follows:

At the time a state or local candidate for elected office files their declaration of candidacy, each candidate shall file a certificate with the officer or board with whom such candidate files the declaration stating that such candidate has been tested for illegal drugs and prescription medication which has not been prescribed for the candidate within fifteen (15) days prior to filing the declaration of candidacy for state or local office and that the results of such test are negative. The test shall be conducted at the expense of the candidate.”

Representative Terrill raised a point of order stating that the fiscal summary was pending and therefore insufficient for consideration of the amendment.

The Presiding Officer stated that the fiscal summary was now available on the computer for the members.

Representative Stiles asked a ruling of the Presiding Officer whether the Shelton amendment is germane to **HB 2388**.

The Presiding Officer ruled the point not well taken and the amendment germane and in order for consideration.
